'Can EU CAP it?'

European School Competition: Compete with your class in the CAP Game for a chance to win a fully funded 3-day trip to Rome & more

Definitions:

'Groupe de Bruges' means the 'Can EU CAP it?' Project, Game & Event Organiser (more information about Groupe de Bruges on www.groupedebruges.eu)

'Entry form' means the website page on the Can EU CAP it? Website www.caneucapit.eu, which must be completed in order to participate in the CAP Game

'Participant' means the person named on the Entry Form who will be participating in the CAP Game

Terms and conditions

1. OBJECTIVES

The 'Can EU CAP it?' European School Competition offers school classes of young people from Europe an opportunity to learn about the oldest European policy: the Common Agricultural Policy (CAP), test their knowledge and playing skills.

The 'serious game'¹ constitutes an explanation of the reformed CAP in simple terms for those that do not know anything about European policy. Topics that will appear include: The Future of farming, the Future of rural areas, Sustainable management of natural resources and Food security, food safety and food quality.

2. ELIGIBILITY

Participants are required to notify their teacher about their participation in the European School Competition. Without the consent of the teacher, participants cannot be selected as winner.

Only Participants who complete the full Entry Form (e-mail, name, school name, date of birth, class number or ID, teachers name, teachers email address, country) on the Can EU CAP it? Website, and that have accepted these Terms & Conditions will be entered into this prize draw to win one of the prizes, as described in these terms and conditions below.

Participants competing in the European School Competition must be students in secondary school education or its equivalent in European countries that are member of the European Union and must be aged 16 years or over. Employees of Groupe de Bruges, their families, agents or anyone else professionally associated with the draw are exempted for participation.

If the winner is under 18 years old he or she can only travel with written consent of his or her parents. If he or she chooses to travel to the location with their parents/guardian/or other relatives, it is not the responsibility of Groupe de Bruges to secure the accommodation or flight tickets. Children (winner under 18) not travelling with parents must be permitted to travel and provide signed letters of authority from parents/guardians.

¹ 'Serious game' is a term used in the gaming industry to distinguish this type of games from the regular games that have been developed for entertainment purposes only. Serious games are a combination of entertainment and education

Terms & conditions

This prize draw is open to residents of the European Union (EU), European Economic Area (EEA), European candidate and Potential candidate countries.

The Groupe de Bruges will ask the winner to provide proof of age and/or country of residence.

3. HOW TO ENTER THE CONTEST

Entries must be submitted via www.caneucapit.eu/game, selecting the “European School Competition” and filling out the entry form. The number of entries is not restricted – **anyone can attempt to play the game as many times in order to score the highest points**. The users **MUST** fill in the whole Entry form, otherwise their identification will not be possible.

Late, illegible, incomplete, defaced or corrupt entries, or entries sent through agencies and third parties, will not be accepted. No responsibility can be accepted for lost entries and proof of sending will not be accepted as proof of receipt.

4. TIMETABLE

The timetable for the ‘Can EU CAP it?’ European School Competition is as following:

- European school competition game will run **from Thursday November 27th, 2015 until midnight Friday February 6 2015** inclusive (CET).
- On Monday February 9, 2015 a Groupe de Bruges jury will determine the winning school team with the average highest score and the individual winner, which is the participants with the highest score of the winning school class.
- The winner and their Teacher will be contacted via email address - provided by participant during the registration process - by 7pm CET on Monday, February 9, 2015 and **will be required to confirm acceptance** of their prize by 9pm CET on Monday, February 16, 2015 **in writing** (via email).

The Groupe de Bruges reserves the right to award the prize to an alternative winner, drawn in accordance with these terms and conditions (2nd highest score and so on) in the case that the Groupe de Bruges is unable to contact the winner, or if the winner is unable to confirm the acceptance of the prize within these deadlines.

5. SELECTION OF WINNING SCHOOL CLASS AND WINNING STUDENT AND PRIZES

There is one prize available for the school class with the highest average score. The average score is calculated by adding the highest scores of each student of a school class, which has registered for the European School Competition, divided by the number of students registered for the European School Competition of that school class. In the case that two or more school classes have reached an equal average high score, the judges formed by Groupe de Bruges employees shall randomly select the one winner among them. Similarly, if two or more students from the winning class have an equal high score the judges formed by Groupe de Bruges employees shall randomly select the one winner among them

The winning school class will receive

- European wide media attention for their class and school, as the project will be covered in wide range of EU media both online and in paper;
- An Amazon voucher for a total value of EUR 250 for the class.
- The student with the highest overall score of the winning class will be invited to represent the school at the closing event of the “Can EU CAP it?” event in Rome on March 18, 2015 – the whole trip is fully funded!;
- A certificate signed by the Commission for Agriculture and Rural Development.

6. PRIZE AWARD CONDITIONS

Terms & conditions

The prize for one student with the highest score of the winning class that will be invited to represent the School in a public debate event will include a 3 days stay (2 nights in total) in an accommodation selected and booked by the Groupe de Bruges, meals (these include 2x breakfast, 2x lunch and 2x dinner for the winner to a total maximum amount of € 140 all together); return flight from an European destination (ticket from within the EU/EEA or European Candidate countries) from 17th of March – 19th of March 2015, as described in these terms and conditions. The winner **ACCEPTS** such date and must provide the Groupe de Bruges written confirmation of which airport he or she wishes to travel from. The return flight will be provided to the same country/airport. The winner must also provide the Groupe de Bruges with his or her personal details in order to purchase flight tickets on his or her behalf. The Groupe de Bruges assures that these personal details will be used only for this purpose.

Please note that for all the meals the winner has to purchase, he/she will be reimbursed after submission all of the receipts/tickets/bills and filling in relevant Groupe de Bruges internal form (bank details for money transfer).

The Groupe de Bruges will book the flights on the winner's behalf within 3 days of his or her written confirmation of the airport and assuming he or she will provide all necessary personal details with that confirmation as well. Boarding passes will be sent to the winner in order for him or her to print the tickets to be able to board the plane. Flights will be made in Economy class departing from any EU or EEA area and cannot be upgraded. Once the flight booking is confirmed changes to the names, date or nature of the booking are not permitted.

The prize is not transferable, redeemable or exchangeable in any other form. It is non-transferable and cannot be exchanged for a cash equivalent.

Please know that Groupe de Bruges can't be responsible for any Visa arrangement. Insurance and additional travel costs is not provided and are the responsibility of the prize winner.

The travel prizes exclude: any extra costs both in the accommodation, during the transport to/from Rome (such as extra legroom, speedy boarding, hold luggage, sport equipment) or in the location of the event (or during). Travel insurance, food and drink (besides the 2x breakfasts, 2x dinners, 2x lunches that are provided for the winner), personal expenditure and incidental costs, are also not included and will not be reimbursed. Where appropriate, it is the responsibility of the individual winner to ensure they he or she has a valid passport or National Identity Card before travelling.

Please know that the following items might incur an extra cost for the winner and will not be reimbursed by the Groupe de Bruges: meals/drinks on board or in restaurants, excursions, alcoholic drinks, on board shopping; transfers to airport in the resident country of the winner; room service; laundry service; alcoholic beverages; any telephone calls; merchandise and souvenirs; incidental expenses; additional tips and gratuities; service charges; income taxes and all other costs and expenses not otherwise mentioned herein.

There will be an accommodation available and booked on behalf of the winner by the Groupe de Bruges in reasonable distance from/to the location of the Event. Groupe de Bruges is not responsible for any costs that endure from/to the location of the Event by the winner.

Once the accommodation booking is confirmed changes to the names, date or nature of the booking are not permitted.

It is the responsibility of the winner to inform the prize provider of any wheelchair or similar access requirements for the winner and/or their companion when taking up the prize, and to adhere to any applicable health and safety guidelines.

Terms & conditions

The winner must comply with the terms and conditions of the airline and other transportation involved in the Competition.

The winning student of the winning class agrees to attend the Public debate Event in Rome for approximately 3 hours during their stay on day two (18th of March 2015) and to have his or her photograph taken at the Event, which will be used for general marketing purposes. Photograph should include photographs taken with the Groupe de Bruges coordination team and with a 'Can EU CAP it?' CAP Game winner certificate.

Groupe de Bruges specifically disclaims liability for any incidental or consequential damages and assumes no responsibility or liability for any loss or damage suffered by any winner as a result of their participation, traveling to/from Rome, use or misuse of any of the information or content on this website.

Groupe de Bruges assumes or undertakes no liability for any loss or damage suffered as a result of the use, misuse or reliance on the information and content on this website. In case of suspicion of fraud, Groupe de Bruges reserves the right to cancel the fraudulent competitors.

7. PERSONAL DATA

All email addresses provided are protected according to the EU General Data Protection Regulation, Directive 95/46/EC. Groupe de Bruges reserves the right to assign any and all information that we collect from users, or that we otherwise collect in connection with the Site. The information collected during the Competition will not be provided to third parties, but might be however used to Groupe de Bruges promotional purposes.

The personal data collected and further processed will be:

- Data necessary for the management of the contest and the organisation of the winners' travel such as gender (needed for the right title/age/name/surname/E-mail address/phone number/home address/passport details) which are promised to kept discreet.
- Photographs and videos of the winner taken during the Public debate Event.

Personal data such as name and surname is kept as long as follow-up actions to the contest are necessary with regard to the purpose(s) of the processing of personal data as well as for the contest and its related management.

All elements of the prizes are subject to availability, non-transferable and there are no cash alternatives. The prizes are redeemable only by the named winner and must not be sold on to any other party.
